1.0 PRODUCT INFORMATION

1.1 DESCRIPTION

The Tronair Fluid Service Unit is a compact unit designed to provide a source of clean, pressurized fluid for filling reservoirs, bleeding brakes and other maintenance functions.

1.5 FEATURES

- 15 foot hoses
- Pressure gauge
- Shut-off valve for component testing
- 5,000 psi high/low pump provides high flow and high pressure capability
- 5,000 psi pressure gauge
- 4 way valve for testing double acting cylinder

2.0 PREPARATION FOR USE

The Fluid Service Unit is shipped fully assembled, and only the following steps are required to make the unit operational:

- 1. Apply appropriate fluid label on reservoir near fill opening (see Illustrated Parts List)
- 2. Service reservoir fill reservoir with appropriate clean fluid.
- 3. Adjust handle height to suit.

Remove Air from System By:

- 1. Close manual pump release screw (lower right corner of pump base block).
- 2. Open shut-off valve (adjacent to pressure gauge).
- 3. Move pump handle to top of stroke.
- 4. Remove pipe plug located near top side of piston cylinder.
- 5. Lower handle until there is fluid filling (spilling out) the top cavity.
- Re-install pipe plug.
- 7. Flow fluid by actuating manual pump.

3.0 TRAINING

3.1 TRAINING REQUIREMENTS

The employer of the operator is responsible for providing a training program sufficient for the safe operation of the unit.

3.2 TRAINING PROGRAM

The employer provided operator training program should cover safety procedures concerning use of the unit in and around the intended aircraft at the intended aircraft servicing location.

3.3 OPERATOR TRAINING

The operator training should provide the required training for safe operation of the unit.

NOTE: Maintenance and Trouble Shooting are to be performed by a skilled and trained technician.

4.0 OPERATION

4.1 FLUID SERVICE UNIT OPERATION

- 1. Securely attach hose(s) to the aircraft.
- 2. Close pump release screw.
- 3. Open shut-off valve.
- 4. Select output hose #1 or #2 by rotating handle pointer to selected hose.
- 5. Transfer hydraulic fluid by actuating the manual hydraulic pump.

When Service Has Been Completed:

- 1. Open pump release screw to relieve hydraulic pressure.
- 2. Disconnect hose(s) from aircraft.
- 3. Install hose end dust plug.

4.2 COMPONENT TESTING

A shut-off valve has been provided to assure no back flow of fluid and therefore is to be closed after the required pressure has built up in the system.

Pressure is relieved by opening this shut-off valve and pump release screw.

5.0 TROUBLE SHOOTING

PROBABLE CAUSE	CORRECTIVE ACTION
High pressure leaks (at joint, plugs or tubing)	Re-tighten or repair
Leaky discharge check valve	Pump rapidly to dislodge; Or repair pump
Leaky release valve	Tighten release valve
Leaky pump O-ring packing	Repair pump
Lack of oil	Refill reservoir check system for leaks
Sticking inlet check valve	Pump rapidly to dislodge; Or repair pump
Closed air vent	Open air vent

6.0 MAINTENANCE

6.1 REMOVING AND SERVICING PUMP

NOTE: If pump is found faulty, call the factory for replacement or replace seals as follows:

- 1. Review Appendix I: Hand Pump Parts List during the following procedure.
- 2. Clamp suction (push on) hose and remove hose from pump.
- 3. Uncouple fitting of hydraulic hose from pump.
- 4. Remove pump from unit.
- 5. Remove cotter pins from clevis pins.
- 6. Remove four (4) socket head cap screws.
- 7. Remove flanges.
- 8. Remove tube assembly (Item 39).
- 9. Replace O-rings and backup ring. (See Appendix I: for available kits.)
- 10. Re-assemble in reverse order.

6.2 FILTER MAINTENANCE

The main pressure has a replaceable element that is **not** cleanable. It is recommended that this filter be changed **annually**, or whenever a **reduced maximum flow** is noticed. Refer to the parts list for the correct filter element number.
